Dignity for All Students Act

- The Dignity for All Students Act
 - Effective July 1, 2012
 - (Chapter 482 Laws of 2010)

Goal: To end bullying, prevent future incidents of bullying, ensure the safety of all, and obtain prompt and equitable resolution of a complaint.



Dignity for All Students Act

Amendment to the Dignity Act

- Effective July 1, 2013
- (Chapter 102 Laws of 2012)

Cyberbullying – social media, texts, e-mail...

- Harassment or bullying by any form of electronic communication
- Includes incidents occurring off school property that create or would foreseeably create a risk of substantial disruption within the school environment.

Pause Before You Post...



Questions to ask yourself...

- –Would anyone be embarrassed or hurt by what I published?
- —How would I feel if someone posted this about me?
- —How would I feel if the things I published caused someone to hurt themselves or others?

Pause Before You Post...



- Questions to ask yourself...
 - —How would I feel if the head of my dream job or the president of my dream college/university saw what I published?

- More colleges and employers are looking at individual social media accounts & posts!
- Once posted electronically, it is potentially out there forever!

Pause Before You Post...



- Questions to ask yourself...
 - —Who will be able to see what I published?
 - —What would my parents, family, or teachers say if they saw what I published?
 - —Is what I posted illegal?
 - Pictures/Sexting
 - Threats
 - Harassing statements/comments, etc.
 - Libelous Statements

"Hacking" someone's accounts/assuming identity of someone else — USE SELF-CONTROL!!!!!!

> § 156.05 Unauthorized use of a computer

- A person is guilty of unauthorized use of a computer when he or she knowingly uses, causes to be used, or accesses a computer, computer service, or computer network without authorization.
- Unauthorized use of a computer is a class A misdemeanor.

- § 156.20 Computer tampering in the fourth degree.
 - A person is guilty of computer tampering in the fourth degree when he or she uses, causes to be used, or accesses a computer, computer service, or computer network without authorization and he or she intentionally alters in any manner or destroys computer data or a computer program of another person.
 - > Computer tampering in the fourth degree is a class A misdemeanor.
- If the suspects intent was to do further harm (ie. steal money, access a bank account, or cause monetary loss) the charges could rise to a felony level.

Pause before you post...

Sexting

- The taking, sending, and receiving of nude or sexual photos or videos by electronic means, such as a text message.
- Sharing nude photos of children can result in convictions for child pornography and other serious crimes.

New York State Law – It is a CRIME to...

- Persuade/solicit someone younger than 17 to engage in the making of a sexual or nude image
- Distribute or disseminate child pornography featuring someone younger than 17 (called promoting a sexual performance by a child).
- "Send me a nude pic"
 - Don't ask for them and don't send them!
- Charges of HARASSMENT for any age

Brighton Believes <u>Self-Control</u>



New York Law

- It is a crime to possess a nude or sexual depiction of someone younger than 16.
 - For example, a teenager who shares a nude photo of a 14-year-old girl with his friends could be convicted for possessing and distributing child pornography, regardless of their age.

 The friends could also be convicted of possession of child pornography.

Brighton Believes Self-Control

Pause before you post...



> Sexting

- Sending or receiving sexually explicit images COULD result in both the sender and receiver being charged with an offense (up to felony levels crimes).
- Juveniles (under 16) would be referred to Family Court if the charges rise to a misdemeanor.
- Teens 16 and older charged as an adult
- BPD routinely consults with the District Attorney on a case by case basis before arresting.

Sexting – laws that might be violated

§ 235.21 Disseminating indecent material to minors in the second degree.

Class E felony.


§ 260.10 Endangering the welfare of a child.

Class A misdemeanor.


§ 250.55 Dissemination of an unlawful surveillance image in the second degree (w/o consent)

Penn Yan, N.Y. (WHAM) - Four minors were arrested in the Penn Yan area after reports of sexting came out over the last month.

This stemmed from a report on August 22 (2016) of several local young people exchanging nude photos through Facebook Messenger.

Penn Yan Police officers and Yates County deputies executed a search warrant on August 26 at a 16-year-old boy's home in Rock Stream. Several cell phones, computers and digital media storage devices were seized.

An investigation found the 16 year old had sent nude photos of himself to an 11-year-old girl in Penn Yan. This led officers to a 13-year-old boy in Himrod who sent a nude photo to himself to the same 11-year-old girl in Penn Yan, as well as a 17-year-old girl from Potter who sent photos of others to the 11-year-old girl.

In addition, the 11-year-old girl sent several nude photos to the other three involved.

The 11-year-old was charged with disseminating indecent material to a minor. The 16-year-old boy was charged with five counts of second-degree disseminating indecent material to a minor. The 13-year-old boy was charged with second-degree disseminating indecent material to a minor and endangering the welfare of a child. The 17-year-old girl was charged with endangering the welfare of a child.

The 16-year-old boy and 17-year-old girl were charged as adults, while the 11 and 13 year olds were charged as juveniles and will answer their charges in Yates County Probation Department. All four names are being withhold due to their status as minors, regardless of the nature of the charges against them.
